ELIGIBILITY & CRITERIA

CRITERIA – bcu Bill Ussher Scholarships

There are ten Bill Ussher Scholarships of \$2,000 each.

To be eligible, applicants must:

- be enrolled at a secondary school (either government or private) studying full time with a current student ID card, or be a full-time apprentice or trainee with a current letter of employment;
- be over 16 years of age as at 16 September 2020;
- be an Australian citizen or resident;
- be a member of bcu or a dependent/child/grandchild of a member of bcu.

ASSESSMENT

All eligible complete applications received by bcu by the stated deadline will be forwarded to the bcu judging panel. bcu reserves the right to verify any information contained in an application with an applicant's nominated referee. The bcu judging panel will review all eligible complete applications and select the recipients to be awarded the scholarships based on the eligible complete applications and (where applicable) verification with an applicant's nominated referee. The panel's decision is final, provided that if bcu determines after the panel makes a decision that a selected scholarship recipient is not eligible or that their application is incorrect, false or misleading in any respect, bcu reserves the right not to award a scholarship to that person.

Applications for the bcu Bill Ussher Scholarships open 9:00am (AEST) Wednesday, September 16, 2020 and close 5:00pm (AEST) Friday, November 6, 2020. No responsibility will be accepted by bcu for late, lost, misdirected or ineligible entries.

AVAILABILITY

The scholarship will be available to ten eligible persons in any recognised secondary school (either government or private) school, or students who are a full-time apprentice or trainee.

VALUE

Each scholarship will have a value of \$2,000.

PAYMENT

Scholarship recipients will receive their scholarship by a one-off lump sum payment of \$2,000.00 credited into their nominated bank account. Funds must be credited into a bank account held in the name of the recipient.
